

# ***AUTO-SWIVEL FUNCTIONALITY***

---

*In order for this Auto Swivel to function perfectly your lines need to be set up untwisted. When setting up your kite ensure your front lines & your CL ropes are clear of any twists.*

## ***Proper Setup Required:***

*Ensure your front lines are untwisted during set up*



*The Sentry Bar comes equipped with Auto-Swivel Functionality. This means that as you twist and rotate your lines you can simply pull in on your bar to untwist them due to the Double PU Coated CL rope running through our Dual Chambered Center hole.*



# ***CLICK IN PUSH AWAY SAFETY***

---


*Slingshot's Sentry control bar comes with a state of the art push-away safety release system. This system is simple, reliable and highly effective. When used properly, activating the safety release will allow your kite to depower completely as it flags-out on the safety line attached to your kite leash.*

- 1. Attach your safety leash to the D-Ring below the Click In Quick Release.*
- 2. To activate the safety release, simply grab the red handle on the release mechanism just above the chicken loop assembly and push it away from your harness. This will release the chicken loop and allow kite to flag-out and safely depower.*




## ***CLICK IN PUSH AWAY SAFETY (CONT.)***

---

- 3. To reset after deploying the release, follow your safety leash and the safety line until you reach your bar, making sure not to get tangled in your lines in the process. Once at your bar, re-engage the safety system by simply pushing the end of the chicken loop into the bottom of the quick release*
- 4. To relaunch, feed your center line through the bar until all four lines have tension, and then relaunch as usual.*

# ***POWER AND DEPOWER***

---

*The Sentry comes equipped with an above-the-bar trim and depower system. Sheeting-in and sheeting-out with the bar should be your primary means of power and depower.*

*This is done by simply pushing the bar out for less power, and pulling the bar in for more power. The Sentry control system operates like a normal and traditional kiteboard control bar.*

## ***POWER AND DEPOWER (CONT.)***

---

*In addition to sheeting the bar in and out, you can manage power by lengthening or shortening your depower rope. For less power, pull down on the rope and cleat it at the desired length. For more power, disengage rope from the cleat and allow it to pull through to the desired length.*

*The Sentry trim block comes with a velcro attachment area. This is for the excess depower rope when you are riding depowered, simply place the end of the trim rope to the cleat to velcro it out of the way.*

## **PUSH AWAY QUICK RELEASE LEASH**

*To completely disconnect yourself from the kite, firmly grasp the red safety handle on your leash and push it away from your body to completely release yourself from the kite.*
